### NOTICE OF BY-ELECTION 2012: 23 August 2012 ( 0800hrs ) to 30 August 2012 ( 1900hrs )

- 2. A short profile of each candidate is enclosed for your information. A soft copy of the individual's profile can also be found at the Singapore Dental Council's ("SDC") website at <a href="http://www.sdc.gov.sg">http://www.sdc.gov.sg</a>. Candidates may canvass for votes "tastefully" without bringing the profession into disrepute. Candidates are also advised to refrain from making comments about the other candidates.
- 3. Polling will be carried out with the **24-hour Automated Telephone Voting System**. If you have access to a "tone phone" (a key-pad telephone with 10 numerals, the asterisk "\*" and hex "#" keys), you may cast your votes even while overseas.
- 4. To vote, login with your **Dental Council Registration Number** and a random **Voter Identification Number**, which will be sent to you shortly by **registered mail**. Each candidate will be identified by a 2-digit code number. Key in the candidate's code and the selected candidate will receive your vote.
- 5. After you have successfully voted for the candidate, the system will issue you with a **4-digit confirmation number**. Make a note of this number, as it will indicate that you have successfully voted.
- 6. **Voting is compulsory**^. Even if you do not wish to vote for any of the candidates, you are required to call the voting hotline to cast a **blank vote**, that is, cast your vote for the nameless candidate, i.e., "candidate double-zero ("00")". Please note that only <u>fully</u> registered dentists are eligible to vote in this By-Election. Dentists with conditional or temporary registration in the Register of Dentists are not eligible to vote.
- 7. Failure to vote could result in you being denied the privilege of renewing your practising licence unless you pay a fine of \$500 to the Singapore Dental Council. The Singapore Dental Council sincerely hopes that it does not need to impose such sanctions.

Please note the polling period is from 23 August 2012 ( 0800hrs ) to 30 August ( 1900hrs ). We look forward to your participation in the By-Election.

Dental Council By-Election 2012

<sup>A Dental Registration Act (Chapter 76)
Compulsory voting
5. (1) Every fully registered dentist whose name appears in the first division of the Register of Dentists and who —

(a) is resident in Singapore; and

(b) has in force a practising certificate on the day of election of candidates as members of the Council referred to in section 3(2)(f),

shall vote for the election of such members at such time and in such manner as may be prescribed.</sup> 

<sup>(2)</sup> Where a fully registered dentist whose name appears in the first division of the Register of Dentists is required to vote for the election of the members of the Council under subsection (1) and fails to do so, he shall not be entitled to apply for a practising certificate unless he —

(a) satisfies the Registrar that he had a good and sufficient reason for not voting at the election; or
(b) pays to the Council a penalty as prescribed by the Council.




