At the first Council meeting held on 15 May 2012, it was decided that a by-election be held to fill the vacancy for an elected member in accordance to section 8(4)¹ in the Dental Registration Act.

- 2. As there is <u>one vacancy</u>, you may propose or second not more than <u>one nominee</u>. The person you nominate must consent to be a candidate in this election.
- 3. Your kind attention is drawn to <u>Section 7²</u> of the <u>Dental Registration Act (Chapter 76)</u> (the "**Act**"), stating who may **NOT** qualify as a member of the Council. If you intend to run as a candidate in this election, you should familiarize your self with the <u>relevant provisions of the Act and the Dentists Regulations</u>**. Parts of the Act pertaining to this election and to the Council are reproduced on Annex A for reference.

4. Nominations close at <u>1700hr on Tuesday, 3 Jul 2012</u>. You may hand in your Nomination Form at the Council's office (located at 81 Kim Keat Road #09-00 Singapore 328836) to Ms Stella Goh, Ms Norisah Ahmad, Mr Shawn Chua or Ms Jerlynn Tan. Alternatively, you may send the same by registered mail or recorded delivery (NOT by ordinary mail, please). Submissions of nominations by email or fax will be deemed invalid.

Dental Council By-Election 2012

1 Filling of vacancies

² Disqualifications for membership of Council

7. No person shall be a member of the Council if -

- (a) he is not a citizen or a permanent resident of Singapore;
- (b) he is not a registered dentist or registered oral health therapist;

(c) he is an undischarged bankrupt;

- (d) he has been convicted in Singapore or elsewhere of any offence involving fraud or dishonesty, or implying a defect in character which makes him unfit for his profession;
- (e) he has been found guilty in Singapore or elsewhere of any improper act or conduct which brings disrepute to his profession;

(f) he has been found guilty in Singapore or elsewhere of professional misconduct; or

(g) his fitness to practise dentistry is judged by the Health Committee to be impaired by reason of his physical or mental condition.

^{8. (4)} If any vacancy arises among the elected members, the Council shall, as soon as practicable, take the necessary action for the election of a person to fill the vacancy.
