#### **TCM PRACTITIONERS BOARD NOTICE 2022/2**

To all registered TCM Practitioners

#### SETTING MAXIMUM CPE CAP FOR CATEGORIES 3A AND 3B LEARNING ACTIVITIES

It has been two years since the compulsory Continuing Professional Education (CPE) programme was implemented on 1 April 2020. Due to the outbreak of the COVID-19 pandemic, the TCMP Board allowed for the CPE requirements to be fulfilled from all categories with no maximum CPE point cap, and TCM practitioners were asked to participate in online CPE events organised by our event providers in view of with the prevailing safe management measures.

## Revision in Category 3A and 3B

To encourage TCM practitioners to continue learning with a multifaceted approach, the Board has decided to set a maximum point cap for Category 3A and Category 3B for the CPE qualifying period starting from 1 April 2022 to 31 March 2024. The maximum number of CPE points for Category 3A and Category 3B will be as follows:

Changes for the Qualifying Period (1 April 2022 – 31 March 2024)					
Category 3A (self-directed learning e.g., reading of TCM / medical books / recognised professional journal)	Maximum cap of 30 CPE points				
Category 3B (online education with assessment)	Maximum cap of 20 CPE points				

- 3 Under Category 3B online education with assessment, CPE providers will help TCM practitioners to improve the learning and understanding through the assessment questionnaire.
- 4 TCM practitioners can continue to expand their knowledge in TCM through reading of TCM/medical journals and attending the many courses (online and on-site) offered by our accredited event providers. For details on the CPE requirements and points, please refer to Annex A.

## Support available for TCM Practitioners to attend CPE courses

## **TCM Development Grant (TCMDG)**

The Ministry of Health launched the \$5 million TCMDG on 1 Jan 2018 to support capability and capacity building of the TCM industry. The scope of support includes training, IT adoption and enhancement of facilities to improve the standards and delivery of TCM care. In summary, the grant will support professional development on three fronts:

- a) <u>Individuals:</u> To provide funding support for skills and professional development for registered TCM practitioners and allied healthcare workers (herbal dispensers and TCM clinic assistants).
- b) <u>TCM course providers:</u> To increase the number and quality of TCM courses by extending funding support to accredited TCM course providers (private and VWOs) to conduct local TCM conferences, seminars and workshops, or other training programmes for professional development of TCM practitioners and related personnel.
- c) <u>TCM clinics:</u> i) To strengthen the operating capabilities of TCM services providers through adoption of IT solutions. ii) To enhance basic TCM clinic facilities for better infection control and to meet the needs of elderly patients.

### Support for individuals: Registered TCM practitioners

- 2. The TCMDG provides support for 80% of course fees, capped at \$200/year, to support professional training of all registered TCM practitioners. All courses approved by the TCM Practitioners Board (TCMPB) will be eligible for claims.
- 3. Applications for claims should be made via the MOH online application form, accessible via the TCMDG website at www.moh.gov.sg/research-grants/traditional-chinese-medicine-development-grant. Application will open around July and close on 31 Dec of each calendar year.
- 4. Application may be submitted once the \$200 claim cap has been reached, or before 31 Dec. For administrative efficiency, training fees incurred for the whole year should be collated and submitted in one application. Receipts of payment indicating the TCM practitioner's name, course title, amount and date of payment are required to be uploaded as part of the application.
- 5. MOH has appointed the Academy of Chinese Medicine, Singapore (ACMS) as our agent in reimbursing claims to all individuals. Reimbursements will be made within the first quarter of the following year by the ACMS.
