<sup>1</sup> Health Products (Cosmetic Products – ASEAN Cosmetic Directive) Regulations 2007 : the Third Schedule, which lists various prohibited and restricted substances and permitted additives, can be omitted from the hardcopy compilation to be printed for use as reference material for the forensic examination.

<sup>2</sup> Health Products (Therapeutic Products) Regulations 2016 : the Second Schedule, which lists various active ingredients in prescription-only medicines and pharmacy-only medicines, can be omitted from the hardcopy compilation to be printed for use as reference material for the forensic examination.

<sup>3</sup> Poisons Act 1938 : the Schedule, which lists the substances scheduled as poisons, can be omitted from the hardcopy compilation to be printed for use as reference material for the forensic examination.

<sup>4</sup> Poisons Rules (R 1) : the First to Tenth Schedules, which list various substances subject to special requirements or exemptions, can be omitted from the hardcopy compilation to be printed for use as reference material for the forensic examination.

<sup>5</sup> Misuse of Drugs Act 1973 : the First to Fifth Schedules, which list the substances scheduled as controlled drugs, penalty tables and various controlled equipment and materials, can be omitted from the hardcopy compilation to be printed for use as reference for the forensic examination.
