ONLINE REGISTER FOR REGISTERED ALLIED HEALTH PROFESSIONALS & AHPC'S 2013/2014 REPORT ON MASS REGISTRATION

The Allied Health Professions Council (AHPC) would like to draw your attention to new information that is now available on our website.

ONLINE REGISTER NOW AVAILABLE

2 The AHPC's Registers of occupational therapists, physiotherapists and speech-language therapists are now available on the AHPC website. This means that you will be able to search online for occupational therapists, physiotherapists and speech-language therapists registered with the AHPC with the "Search for Registered Allied Health Professionals" function.

3 The information available on the online register includes the following:

- a) Name of the registered allied health professional;
- b) Allied health professional's registration number;
- c) Allied health professional's registrable qualifications;
- d) Allied health professional's date of registration with AHPC;
- e) Allied health professional's type of registration (i.e. full, restricted, conditional or temporary) with AHPC;
- f) Duration of allied health professional's practising certificate; and
- g) Allied health professional's primary place of practice.

Please note that the details of the restrictions and conditions of registration for therapists on conditional registration and restricted registration are not stipulated in the register. Therapists, employers and the public are advised to contact the AHPC if they require clarifications or further details.

Maintaining personal particulars on the register

5 As the online register serves as a means for the public to locate allied health professionals and verify their registration, the AHPC would like to remind all registered therapists to update the AHPC of any changes to their employment so that the information on the registers remains relevant and up-to-date. You may write to enquiries@ahpc.gov.sg if you wish to update your particulars with the subject heading "Update of Particulars".

6 Allied health professionals who are on conditional and restricted registration are also reminded that you must seek approval of the AHPC of any changes related to your employment or place of practice at least one month before the date of the intended change. Prior approval from the AHPC is required before you may commence with your new employment as your registration is only valid with the specified employer in your registration.
