PRESIDENT'S MESSAGE

The 2014 Allied Health Professions Council (AHPC) report rounds off the statistics for the year. Since the end of the mass registration grace period in April 2014, the AHPC has continued to work diligently to improve its processes and manage the increasing number of registered allied health professionals which rose to 2,699 registrants by the end of 2014.

This year also saw a change in the Council's composition with Ms Helen Chandler-Yeo stepping down, and Ms Jacqueline Phang Win Ling who stepped up to take on the appointment as a representative of the Speech-Language therapy profession on 1 August 2014.

After the mass registration grace period, the AHPC began to phase out the grace period supervision requirements as the 2014 Supervised Practice Guidelines came into force. Proper supervision of the conditionally-registered allied health professionals remains one of the key areas of focus for the AHPC so that professionals with little or no prior experience in Singapore are properly assessed and given the opportunity to familiarise themselves with the health and social care systems and practice in Singapore. To this end, 27 Supervisor Training Workshops were organised and 654 supervisors trained in the year 2014 to provide them with the necessary skills and knowledge to supervise conditionally registered therapists.

The Council has been working hard to ensure that our regulatory practices thread the delicate balance of patient safety and the standards expected of allied health professionals. I am heartened by the dedication and commitment of our Council members and colleagues who have served on the various AHPC Committees. We will continue to make our regulation and processes more efficient and look forward to working together with the various professional groups.

INTRODUCTION

The Allied Health Professions Council was formed on 8 April 2013 and the implementation of the Allied Health Professions (AHP) Act commenced on 15 April 2013 with the mass registration of Occupational Therapists, Physiotherapists and Speech-Language Therapists.

The Council maintains the Registers of Allied Health Professionals and renews practising certificates and issues certificates of good standing. The Council specifies pre-registration requisites, approves pre-registration training centres and directs continuing education.

The Council also investigates into any complaints against a registered allied health professions for professional misconduct. Registrants found guilty of professional misconduct may be reprimanded, suspended or removed from the Register.

The Annual Report 2014 documents the activities and registration statistics as at 31 December 2014 which includes the data recorded after the mass registration of occupational therapists, physiotherapists and speech-language therapists which took place from April 2013 to April 2014.

REGISTRATION OF OCCUPATIONAL THERAPISTS, PHYSIOTHERAPISTS & SPEECH-LANGUAGE THERAPISTS

The registration of Occupational Therapists, Physiotherapists and Speech-Language Therapists commenced on 15 April 2013 with a 1-year transitional grace period till 14 April 2014 for all therapists to apply for registration. After this transitional grace period, those who wish to practice had to apply for registration with the Council first before they could start practising.

The registration categories for the Allied Health Professions Council are similar to other healthcare professional boards in Singapore in that the therapists could be registered with full, conditional or temporary registration. Restricted registration was introduced mainly to grandfather existing foreign therapists whose qualifications were not found on the Council's List of Recognised Qualifications, and enabled them to continue practising in their existing roles without the need for supervision under Conditional Registration.

At the end 2014, the Council had registered 2,699 therapists consisting of 905 Occupational Therapists (OT), 1,394 Physiotherapists (PT) and 400 Speech-Language Therapists (SLT).

COMPLAINTS

The Council received a total of four complaints against the therapists since the start of registration. The cases were still under investigation as at 31 Dec 2014.

Physiotherapists continue to make up the majority of registered allied health professionals, followed by occupational therapists and speech-language therapists.

REGISTRATION TYPE

Close to 78% of the registered occupational therapists, physiotherapists and speech-language therapists were fully registered by the end of 2014; with 19% on conditional registration. Majority of the therapists under Conditional registration were newly registered with the AHPC, with some being placed on conditional registration as returners to practice. Therapists under restricted registration make up 2% of the total pool and have been grandfathered in view of their previous work experience in Singapore. After the mass registration grace period, Temporary registration was granted only to visiting experts coming to Singapore to teach.

SECTOR DISTRIBUTION

The public healthcare sector employs the bulk of allied health professionals. Voluntary welfare organisations employ the second highest number of occupational therapists while the private sector hires the second highest number of physiotherapists and speech-language therapists.

DEMOGRAPHIC PROFILE OF REGISTERED THERAPISTS

The therapy professions are female dominated, with the majority of all registered therapists falling within the age group of 20-29, followed by those in the 30-39 age group. Singapore citizens and PRs make up almost 70% of the pool across the three professional groups. **Table 5** shows the demographic profile of registered therapists, namely gender, age, and nationality.

Chart 2a. Total number of registered therapists by gender as at 31 December 2014







Chart 2b. Registered therapists by age group as at 31 December 2014








THERAPISTS WHO HAVE COMPLETED AHPC'S SUPERVISOR TRAINING WORKSHOPS
